FY20 Dividend and Dividend Reinvestment Plan Information

Bravura Solutions (Bravura) today announced its FY20 financial results. Details of the FY20 final dividend are provided in the table below. Bravura's dividend reinvestment plan (DRP) will operate with respect to the FY20 final dividend.

As noted in the DRP rules announced on 30 January 2019, the pricing period refers to the period of 10 trading days commencing on the second trading day after the record date. The DRP price is the arithmetic average of the daily volume weighted average market price (rounded up to the nearest cent) of all shares traded in the ordinary course on the ASX during the pricing period, less any discount as determined by the Directors.

The Directors have determined that a discount of 2.0% will apply under the DRP with respect to the FY20 dividend. Any shareholder who wishes to commence participating or vary their current participation election in the DRP should do so by logging onto the Link Market Services website at www.linkmarketservices.com.au or by completing the DRP form available at the Link Market Services website by 5:00pm on 8 September 2020.
