Bravura Solutions implemented a hosted system in advance of the 2019 salary review. Bravura Solutions understands the importance of supporting employees with responsibilities outside of work through enabling and encouraging flexible working arrangements. These policies and strategies are well received and utilised by many employees. Having the ability to work flexibly enables a positive work-life balance for our employees, and also sustains a diverse workforce. Employees may need to adapt their working arrangements as a result of external factors such as family obligations, caring responsibilities, health factors, etc. and Bravura employees are readily enabled and empowered to respond to these changing circumstances while ensuring a sustainable work-life balance. While our Parental Leave Policy is well received, we are currently undertaking a review of this benefit. This includes assessing the possibility of increasing the number of paid parental leave weeks available to both the Primary and Secondary carer. In addition to this, Bravura is working on developing more initiatives for employees returning to work after a period of parental leave. We are seeking to provide more structure and support for these employees during the transition back to work, and ultimately advocating a healthy work life balance.

Bravura Solutions has made great progress over the reporting period on consulting and involving employees on gender equality. We consulted with our employees on gender equality by undertaking an inaugural companywide engagement survey, which includes questions about gender equality in the workplace. These surveys are anonymous and allow for honest feedback through both closed and open-ended questions. This data is then analysed and used for overall development by enabling the company and its directors to understand which issues require more focus from the perspective of an employee. Gender equality in the workplace is also covered in our Manager Development Program. All managers are given mandatory training and are educated on a wide range of topics; gender equality and diversity is a theme throughout the program. Bravura celebrates International Women's & Men's Day each year. In 2019, Bravura celebrated each day by holding seminars and sessions in each location within Australia, these sessions were held onsite and all employees were encouraged to participate in a range of discussions, and to learn from various guest speakers who covered a range of topics. Another initiative which was established in 2019 is the Bravura Women's Network Forum. This is an advisory group; made up of Senior female Managers who meet quarterly to identify issues in relation to gender diversity and to discuss progress against our Diversity and Inclusion targets. In addition to this, Bravura is working on establishing a Diversity & Inclusion Leadership Team. This team of business leaders will be responsible for ensuring that our Diversity & Inclusion strategy is articulated in our day to day practices.
